



**SAFTI FIRST LIFETIME LIMITED WARRANTY ON FIRE PROTECTIVE MONOLITHIC GLAZING**

SAFTI FIRST warrants SuperLite I, SuperLite I-XL, SuperClear 45-HS, SuperClear 45-HS-LI and SuperLite X-45/60/90 for the entire life of the product from the date of delivery, *provided that said products have been transported with proper inspection, stored, installed and maintained in accordance with SAFTI FIRST's installation instructions and published maintenance recommendations.*

Remedies for valid warranty claims shall be limited to either the repair or replacement of defective products at SAFTI FIRST's discretion. SAFTI FIRST shall not be liable for any additional expenses, including, but not limited to: labor, materials, and/or equipment to remove defective products; any occupant relocation; temporary protection; remobilization; or any labor, materials, and/or equipment or installation of warranted product.

This SAFTI FIRST limited warranty is non-transferrable and extends only to the immediate buyer.

Fire protective glass may have irregularities that do not affect the free vision through the glass and are inherent in the processes in making these products.

Proper protection of glazing surfaces must be maintained.

In no event will SAFTI FIRST be liable for direct, indirect, special or consequential damages including but not limited to loss of profit or use.

The warranty shall not apply to units which have not been handled in accordance with normal conditions of use, or units which have been subsequently processed or modified in any way, or units which have been subject to any damage including scratching and breakage.

Defects are to be reported to SAFTI FIRST within 30 days after they are noticed, or should have reasonably become known, to the buyer, contractor or the users of the structure or location which SuperLite I/SuperLite I-XL/SuperClear 45-HS/SuperClear 45-HS-LI/SuperLite X-45/60/90 has been provided. Any glass replaced or repaired under this warranty is limited by the original warranty period and shall not be extended beyond the original warranty herein provided.

This limited warranty extends only to product sold in North America unless otherwise provided in writing.

Building and safety codes vary widely throughout the U.S. and the world. SAFTI FIRST does not control nor are they responsible for the selection of products regarding the use or compliance with code. SAFTI FIRST is not responsible for products supplied by others. Configurations not standard in the manufacture of glazing products specified by others are not warranted unless specifically agreed to in writing. SAFTI FIRST fabricates to quantities and dimensions furnished and approved by Buyer, and shall not be liable for any variance or discrepancy with jobsite conditions.

SAFTI FIRST reserves the right to inspect or have returned all products alleged to be defective or not complying.
