

**SAFTI FIRST 5-YEAR LIMITED WARRANTY ON INSULATED (IGU) and LAMINATED
FIRE PROTECTIVE GLAZING**

SAFTI *FIRST* warrants SuperLite I IGU, SuperLite I-XL Insulated, SuperLite I-XL IGU, SuperLite I-XL laminated IGU, SuperClear 45-HS IGU, SuperClear 45-HS-LI IGU and SuperLite X-45/60/90 IGU for a period of 5 years from the date of delivery. This warranty applies only to glass products manufactured by SAFTI *FIRST* that *have been transported properly, inspected on receipt, with proper documentation and stored in a protected area.*

This warranty is limited to the glass manufactured by SAFTI *FIRST* only and does not cover glazing or components supplied by others. Defects should be directed to the manufacturer of those glazing components.

This warranty does not cover or include installation or reinstallation of defective products and shall be limited to either the repair or replacement of defective products at SAFTI *FIRST*'s discretion. SAFTI *FIRST* shall not be liable for any additional expenses, including, but not limited to: labor, materials, and/or equipment to remove defective products; any occupant relocation; temporary protection; remobilization; or any labor, materials, and/or equipment or material necessary for the installation of warranted product.

This SAFTI *FIRST* limited warranty is non-transferrable and extends only to the immediate buyer.

Fire protective glass may have minor irregularities that do not affect the free vision through the glass and are inherent in the processes in making these fire rated products.

Proper moisture control, water drainage, and protection of these insulated/laminated glazing unit is required.

In no event will SAFTI *FIRST* be liable for direct, indirect, special or consequential damages including but not limited to loss of profit or use.

The warranty shall not apply to units which have been shipped, stored or handled improperly. Units that have been modified in any way, or units that have subsequent damage including scratching and breakage.

Defects must be reported to SAFTI *FIRST* within 30 days after they are noticed, or should have become known, to the buyer, contractor or the user. Any glass replaced or repaired under this warranty is limited by the original warranty period and shall not be extended beyond the original warranty herein provided.

This limited warranty extends only to product sold and delivered in North America unless otherwise provided in writing.

Building and safety codes vary widely throughout the U.S. and the world therefor SAFTI *FIRST* cannot control or be responsible for the selection of its products in the determination of fitness, use and compliance with code. SAFTI *FIRST* is not responsible for products supplied by others. Configurations not standard in the glazing industry, or which are specified by others unless specifically agreed to in writing. SAFTI *FIRST* makes no other warranties or representation, either express or implied, concerning a product's fitness for a particular purpose other than specifically stated.

SAFTI *FIRST* fabricates to quantities and dimensions furnished and approved by Buyer, and shall not be liable for any variance.

SAFTI *FIRST* reserves the right to inspect or have returned all products alleged to be defective or represented as not in compliance.
