SAFTI *FIRST* warrants that SuperClear 45-HS IGU/SuperClear 45-HS-LI IGU shall be free from defective product for a period of 5 years from the date of delivery, *provided that said products have been transported, stored, installed and maintained in accordance with SAFTI FIRST's installation instructions and published maintenance recommendations.* This warranty is limited to defects appearing in the door, window or wall framing and glazing components manufactured by SAFTI *FIRST*. This warranty is limited to the glass and framing manufactured by SAFTI *FIRST* only and does not cover product or hardware supplied by others. Should there be a defect or operating difficulty with any hardware component, Owner should contact the respective manufacturer and its warranty agreement.

This warranty is limited to the repair or replacement of defective material or entire product, at the discretion of the manufacturer. It specifically does not cover either initial or replacement installation.

SAFTI *FIRST* extends the manufacturer's warranty to the immediate buyer. The conditions of this warranty for the SuperClear 45-HS IGU/SuperClear 45-HS-LI IGU glazing material are as follows:

The supplier warrants its immediate buyers for a period of 5 years from the date of delivery that under normal conditions, discussed below, product manufactured by SAFTI *FIRST* will perform and provide the protections as required for its fire and/or structural ratings. For that period, SuperClear 45-HS IGU/SuperClear 45-HS-LI IGU glazing is warranted to provide free vision through the glass. A degree of optical irregularities is inherent in the nature of specialty fire protective glass meeting CPSC Cat. I and II safety requirements, including some distortion, especially near the glass edges. These inherent irregularities do not affect the free vision through the glass.

The warranty is subject to the following provisions:

- Liability under this warranty is limited to free repair or replacement (at the manufacturer's discretion) of defective glass and/or frames manufactured by SAFTI *FIRST* and shall not extend to other components, installation or to any other damages in connection with defective glass. Installation of the replacement glass into any frame, or into any structure, is not covered under this warranty.
- In no event will SAFTI *FIRST* be liable for direct, indirect, special or consequential damages including but not limited to loss of profit or use.
- The warranty shall not apply to units which have not been handled in accordance with normal conditions of use, or units which have been subsequently processed or modified in any way, or units which have been subject to any damage affecting the units.
- **Normal conditions include maintaining the product (during transport, storage, installation use or otherwise) with proper drainage, such that exterior surfaces are not resting in water.**
- Manufacturer's warranties on component parts of materials may differ from the terms specified herein and will supersede SAFTI *FIRST*'s standard warranty.
- The manufacturer's liability will also not apply unless defects are reported to SAFTI *FIRST* within 30 days after they have become known, or should have reasonably become known, by the buyer of the unit, contractor or by the users of the building into which SuperClear 45-HS IGU/SuperClear 45-HS-LI IGU has been installed. Any glass replaced or repaired under this warranty is limited by the original warranty period and shall not be extended.
- This limited warranty extends only to product sold in North America.
- Building and safety codes vary widely throughout the world. SAFTI *FIRST* does not control nor is it responsible for the selection of product or compliant with any particular code. It is not responsible for product supplied by others, configurations, or the glazing materials used in the manufacture of its door, window or wall systems. SAFTI *FIRST* makes no other warranties or representation, either express or implied, concerning product fitness for a particular purpose. SAFTI *FIRST* will fabricate to dimensions shown on approved drawings and will not take responsibility for any variance between "as built" product and shop drawing dimensions or any job site conditions.
- SAFTI *FIRST* reserves the right to inspect or have returned all products alleged to be defective excluding.
- SAFTI *FIRST* excludes all shipping and handling costs associated with this warranty.
- SAFTI *FIRST* makes no other warranty, express or implied, regarding its products.
